If you do meet with our staff or contractors, please follow the physical distancing and good hygiene government guidelines.



Discovery of illegal works

WMI has been contacted by several shareholders in relation to speculation about the discovery of illegal works tapping into a WMI pipeline.

WMI uses a number of techniques, such as analysis of historical water ordering and usage patterns and ground-penetrating radar, to identify such behaviour.

As a result, we can confirm that illegal works tapping into a WMI pipeline were discovered recently.

WMI regards interference with our water management works and taking water without lawful authority as very serious matters.

It is a criminal offence under the *Water Management Act 2000* (NSW) to:

- destroy, damage or interfere with, or to deposit anything in, WMI's water management works without lawful authority; or
- take water from any water supply work that is owned by, or under the control and management of WMI, without lawful authority.

The maximum penalty for each of the above offences is \$2,002,000 and a further \$132,000 for each day the offence continues.

WMI has reported the circumstances of which it is aware to the NSW Natural Resource Access Regulator for its consideration as to whether criminal offences have been committed and for any appropriate prosecutorial action to be taken as a consequence. In addition, WMI has reserved its own right to commence prosecutions against any responsible persons if it forms the view that offences have been committed.

In the meantime, the customers concerned have been notified that they have committed events of default under their contracts with WMI. As a result, WMI suspended all water deliveries to these customers and required the customers concerned to account for the water taken and delivery charges, among other things.

WMI's investigations into these matters are continuing.

Metering & Telemetry project update

WMI continues the installation of new meters and telemetry units at eligible sites. Over 90% of Coomealla meters are now installed.

Curlwaa & Coomealla generators put to good use

WMI participated in the Australian Energy Market Operator's (AEMO) Reliability and Emergency Reserve Trader (RERT) scheme during the 2019/20 summer period for the first time. The scheme enables AEMO to maintain power system reliability and system security using reserve contracts.

WMI was called to participate on Friday 31 January 2020 between 5:30pm and 8:30pm to assist maintain Victoria's power system reliability. Both Curlwaa and Coomealla generators were turned on to reduce the demand for power whilst maintaining full service to those pump stations and customers' irrigation requirements.

The exercise was successful and WMI is expecting to receive close to \$42,000 as payment for participating.

WMI continues to investigate the feasibility for a generator at Buronga pump station.

End of year surplus allocation water trade

Customers are strongly encouraged to undertake their own individual trade up to the WMI cut-off date of 10am Friday 26 June 2020 to maximise returns.

WMI will however endeavour to trade a proportion of surplus allocation remaining after 10am on 26 June 2020 if economical and practical to do so with acquittal into eligible customer accounts in accordance with the model implemented in the previous seasons.

Additional Water Fee reminder

Water usage above allocation is billed quarterly at \$1,200/ML.

Please ensure you always have a positive water allocation in your account, in order to meet your needs for the current irrigation season.

Customers should contact the office staff for more information or assistance.

Indicative opening allocations on 1 July 2020

NSW DPIE Water has conservatively based the outlook for 1 July opening water allocations on assumed very dry inflows for the remainder of this water year and extreme dry conditions for 2020-21.

It is forecast that NSW Murray high security allocation of 97 percent will be met on 1 July, and general security allocations will be low or zero. Carryover commitments will also be met.

The good news is that the Menindee Lakes System is rising as northern basin inflows continue and is forecast to rise to around 20 percent by the end of April. The inflows have been enough to safely re-start the Lower Darling river and should be sufficient to run the river for at least 12 months, probably longer.

Blue Green Algae Alerts

WaterNSW provides algal alerts on their website: www.waternsw.com.au/water-quality/algae.

The amber alerts continue (as at 23 April 2020) but it is advisable to check the alerts regularly as algal concentrations can change rapidly.




