1. Approval is required by WMI prior to any links being processed.
2. When linking Delivery Entitlements, the account must be in the same irrigation area.
3. All owners (first three listed) associated with both accounts must sign this form consenting to the linking.
4. If Water Above Access Fee Allowance Fee, Casual Users Access Fee or Additional Water Fee – fee for service, remains outstanding on the primary account after the due date, WMI reserves the right to disconnect the supply of water to any or all of the properties involved in this linking application.
