- 1 If Delivery Entitlement Units are held jointly by two or more persons, each person must be named as a party and each person must sign this application. The Applicant's details must be identical to the details on their Water Delivery Agreement.
- 2 There is no application fee in relation to this form.
- 3 The Surrender of Delivery Entitlement Units requires the approval of the Board.¹
- 4 The transaction is subject to the Applicant paying to WMI all outstanding debts and other amounts payable, including Termination Fees.²
- 5 If the Applicant is surrendering all of the Delivery Entitlement Units on their account, the Applicant will be required to pay a disconnection fee.³
- 6 The termination of Delivery Entitlement Units will take effect on the date on which the Applicant gives written notice to WMI.⁴
