

## **SCHEDULE OF CHARGES**

**Valid: 1 July 2024**

This document comes into effect on 1 July 2024 and is valid until a new schedule of charges comes into effect.

Unless specified otherwise:-

- each individual fixed fee or charge applies on and from 1 July 2024 to 30 June 2025;
- each individual variable or other fee or charge applies on and from 1 July 2024 while this schedule of charges is in effect;
- each fee and charge applies in respect of the relevant irrigation area (that is, Buronga, Coomealla or Curlwaa), if any, specified and is payable by customers whose landholdings are in the relevant irrigation area; and
- all fees and charges include GST (if applicable).

The fees and charges in this document relate to the New South Wales Murray Regulated River Water Source and the *Water Sharing Plan for the New South Wales Murray and Lower Darling Regulated Rivers Water Sources 2016* (NSW).

## Definitions

In this document:-

**Additional Water** means the number of ML of water by which a customer has overdrawn their water allocation account, resulting in a negative balance.

**DE** means Delivery Entitlement.

**IPART** means the Independent Pricing and Regulatory Tribunal of NSW.

**MDBA** means the Murray-Darling Basin Authority.

**ML** means megalitre (one million litres).

**Quarter** means a period of three months commencing on 1 July, 1 September, 1 January, or 1 April.

**WAMC** means the Water Administration Ministerial Corporation.

**Water Year** means the 12-month period from 1 July in one calendar year to 30 June in the next calendar year.

**WE** means Water Entitlement.

**WMI** means Western Murray Irrigation Limited.

## Invoicing

WMI invoices its fees and charges quarterly, meaning there are four invoices for the Water Year.

The following fees and charges are divided equally across the four invoices issued for the Water Year:-

- the Account Fee;
- the Meter Service Fee;
- the Asset Replacement Fund Fee;
- the Overdraft Repayment Fee
- the Delivery Entitlement Fee and
- the Fixed Government Charge.

The following fees and charges are levied at the end of the relevant Quarter in which they are incurred:-

- the Electricity Usage Fee;
- the Usage Above Delivery Allowance Fee;
- the Additional Water Fee (where the fee is charged because a customer's water allocation account has a negative balance at the end of the Water Year); and
- the Variable Government Charge.

The following fees and charges are levied at the time they are incurred:-

- the Additional Water Fee (where the fee is charged because a customer's water allocation account has a negative balance after the customer fails to comply with a notice from WMI to bring the balance back to zero or a positive balance within five business days);
- the Disconnection Fee;
- the Permanent Disconnection Fee;
- the Reconnection Fee; and
- the Termination Fee.

### **How WMI's fees and charges are determined**

WMI reviews all fees and charges annually or as required, based on budget recommendations. Generally, fixed fees and charges are determined to recover the costs of operating WMI's irrigation infrastructure. All service requests, including disconnection and reconnection works, are generally determined to recover the cost of the relevant activity. Customers will be invited to give feedback during the annual fee review process. The method for giving feedback will be communicated as part of that process.

### **How pass-through charges are determined**

#### *Recovery of WaterNSW bulk water charges – fixed and variable*

WMI sets these charges to recover WaterNSW charges at the amount set by IPART. IPART sets these charges every four years via a public consultation process. The legislative authority for IPART to determine these charges is section 11 and Schedule 1 of the Independent Pricing and Regulatory Tribunal Act 1992 (NSW) and IPART's WaterNSW determinations. These charges are updated annually if necessary.

The fixed pass-through WaterNSW bulk water charges set out in this document account for the irrigation corporations and districts discount received by WMI from WaterNSW. This discount is determined by IPART so as to reflect costs that are avoided by WaterNSW as a result of WMI carrying out certain activities (such as billing, metering and compliance, telemetry installation and data transfer) that WaterNSW would otherwise be required to carry out. The avoided costs are determined per ML of entitlement cost multiplied by the number of WEs held by WMI customers. To ensure that WMI customers receive the benefit of the discount, WMI calculates the discount per WE held by its customers and subtracts this amount from the WaterNSW bulk water charge incurred by WMI.

#### *Recovery of WAMC charge – fixed and variable*

WMI sets these charges to recover WAMC charges at the amount set by IPART. IPART sets these charges every four years via a public consultation process. The legislative authority for IPART to determine these charges is section 11 and Schedule 1 of the Independent Pricing and Regulatory Tribunal Act 1992 (NSW) and IPART's WAMC determinations. These charges are updated annually if necessary.

#### *Recovery of NSW Government contribution to the MDBA – fixed and variable*



WMI sets these charges to recover the NSW Government's contribution to funding the MDBA to undertake activities under the Murray-Darling Basin Agreement at the amount set by IPART. IPART sets these government charges every four years via a public consultation process. The legislative authority for IPART to determine these charges is section 11 and Schedule 1 of the Independent Pricing and Regulatory Tribunal Act 1992 (NSW) and various IPART determinations. These government charges are updated annually if necessary.

### **Interest**

Interest will be applied to any fees and charges that remain outstanding after the due date. The interest rate, per section 356 of the Water Management Act 2000 (NSW), is:-

- in respect of the period from 1 January to 30 June in any year – the rate that is 6% above the cash rate last published by the Reserve Bank of Australia before that period commenced; and
- in respect of the period from 1 July to 31 December in any year – the rate that is 6% above the cash rate last published by the Reserve Bank of Australia before that period commenced.
