How Western Murray Irrigation’s fees and charges are determined		
Western Murray Irrigation reviews all fees and charges annually or as required, based on budget recommendations. Generally, fixed fees and charges are determined to recover the cost of maintaining and operating WMI’s infrastructure. All service requests, including connection or disconnection works, are generally determined to recover the cost of the activity. DESCRIPTION OF CHARGES	
Charge	Description of the service to which the charge relates
Account Fee	Administering a customer's account with WMI (including preparation of invoices, customer communications and postage).
Meter Service Fee	Operation and maintenance of a meter & outlet including servicing, telemetry (where installed), monitoring, support and compliance.
Delivery Entitlement Fee	Providing a right of access to WMI's irrigation infrastructure and the operation and management of systems.
Asset Replacement Fund Fee	Capital works in respect of WMI's irrigation infrastructure.
Overdraft Repayment Fee	Reducing the overdraft balance created by capital works and operating expenses in the Buronga irrigation area.
Electricity Usage Fee	The provision of electricity to operate pumps used to deliver water to a customer.
Usage Above Delivery Allowance Fee	The supply of water in excess of a customer's Delivery Allowance at the end of the relevant Quarter and the operation and management of systems.
Additional Water Fee	A fee-for-service in respect of Additional Water delivered to, or taken by, a customer in excess of their Water Allocation Account.
Fixed and Variable Government Charge (pass-through charges) – High Security, General Security and Stock & Garden	<ul style="list-style-type: none"> • WaterNSW Bulk Water Charge refers to the collection of charges for the supply of bulk water. • WAMC Murray-Darling Basin Authority (MDBA) charge recovers the costs incurred by the Water Administration Ministerial Corporation (WAMC) for fees levied by the MDBA. MDBA charges NSW for its share of joint programs, including river operations, assessment and environmental oversight. • WAMC charges collected by WaterNSW cover licensing, compliance, water planning and monitoring. • Recovery of Rural Murray-Darling Basin Authority charges relate to supporting management and sustainability of water resources in the region.
Disconnection Fee	Temporarily disabling a physical connection between a customer's works and Western Murray Irrigation's (WMI) works.
Reconnection Fee	Re-establishing a physical connection between a customer's works and WMI's work which had been temporarily disabled.
Permanent Disconnection Fee	Permanently removing a physical connection between a customer's works and WMI's works.
Connection Fee	Establishing a new permanent connection between a customer's works and WMI's works.
Termination Fee	Termination fees are payable in respect of the termination of a right of access in accordance with the <i>Water Charge Rules 2010 (Cth)</i> .
