

From the CEO

The record rainfall event across our region in early March over a short period generated widespread runoff and placed considerable pressure on our drainage network which is designed and maintained for normal irrigation drainage.

Many recorded 200mm plus over those few days, representing 70% of Mildura’s total annual average rainfall. The MDBA has estimated around 200GL of additional water will be captured downstream at Lake Victoria.

I would like to acknowledge the efforts of our team during this period. Staff worked continuously to monitor conditions, clear blockages and assist customers. This was supported by our contractors and additional resources including mobile pumps which were deployed across the district.

We are very aware that this occurred at a critical time for many of our customers, particularly those in the middle of grape and melon harvest and certainly appreciate the cooperation and understanding shown by many. We would encourage any customer financially impacted by this event to contact us to discuss bill payment plan options.

As conditions improved and pumping resumed, our boosted water quality treatment was able to address any odour or growth caused by warm water sitting in pipelines.

Our focus has now shifted to repair and recovery to drainage and other infrastructure impacted by the event.

On behalf of the Board, I thank our staff, contractors and customers for their efforts and cooperation during what has been a challenging period for our region.

Water Allocation Trade – benefits of trading within WMI

Customers wishing to buy or sell water allocation have the option of listing on the WMI Trading Exchange page found on the customer portal.

The benefits of this option include:

- One-off administration charge which is significantly lower than the combined WMI, Broker and State Department approval/processing fees if trading externally
- No broker commission from either party
- Prompt transfer between WMI customer accounts (once payment received)
- Small parcels available

Delivery Allowance Trade

Customers wishing to buy or sell delivery allowance have the option of listing on the WMI Trading Exchange page found on the customer portal.

The benefits of this option include:

- Seller receives funds to offset against their fixed WMI Delivery Fees and the buyer eliminates the premium Usage Above Delivery Allowance Fee (Casual User)
- No broker commission from either party
- Prompt transfer between WMI customer accounts (once payment confirmed)
- Directly connects you to other WMI customers

Customers wishing to **buy and/or sell water allocation or delivery allowance:**

- Log into your customer portal and click on the Trading Exchange button
- View current buy/sell parcels
- Forms, and terms & conditions, are available on this page if you wish to participate.

Third Quarterly Invoice Due for Payment

The third quarter invoice for 2025/26 is now available and due for payment on or before Friday 15 May 2026.

Additional Water Fee Reminder

Water usage above allocation is billed quarterly at \$1,200/ML (or part thereof). Please ensure you **always have a positive water allocation balance**. Customers should contact the friendly office staff for more information.

NSW irrigation corporation fees – 1 July 2026

The NSW Government will be introducing new fees for the state's 5 irrigation corporations from 1 July.

These fees will recover the cost of delivering services that regulate and manage irrigation corporation operating licences.

WMI has been actively involved in the consultation and will be obliged to include these new fees in our upcoming 2026/27 schedule of charges.

End of year surplus water allocation trade

Customers with excess water allocation can independently trade their surplus until the WMI cut-off at 10.00 am on Friday 26 June 2026.

As a result of the complexity introduced by new federal water market rules and regulations, we will no longer facilitate an end-of-year bulk surplus allocation trade on behalf of customers.

Please keep outlets and surface drains clean

Customers are reminded to keep outlets free of weeds, equipment and rubbish, ensuring easy and safe access for our operations staff.

No rubbish, old vine posts or irrigation lines are to be illegally dumped into surface drains.

Temporary closure of WMI Office

WMI will be undertaking planned office renovations commencing 20 April, with works expected to be completed by early July.

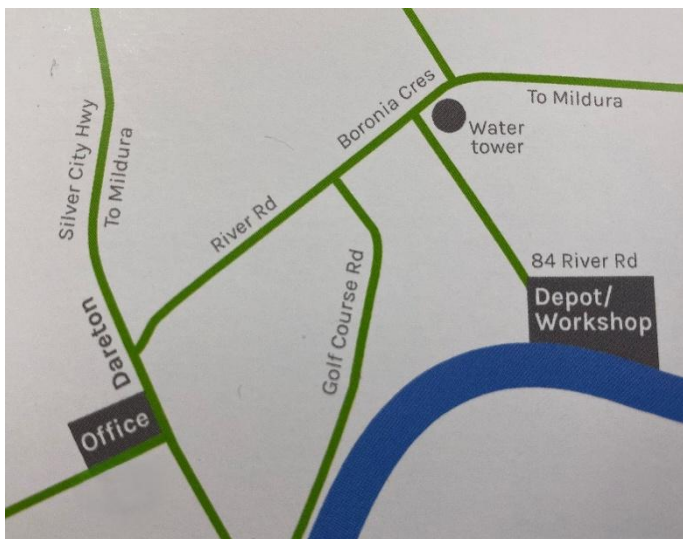

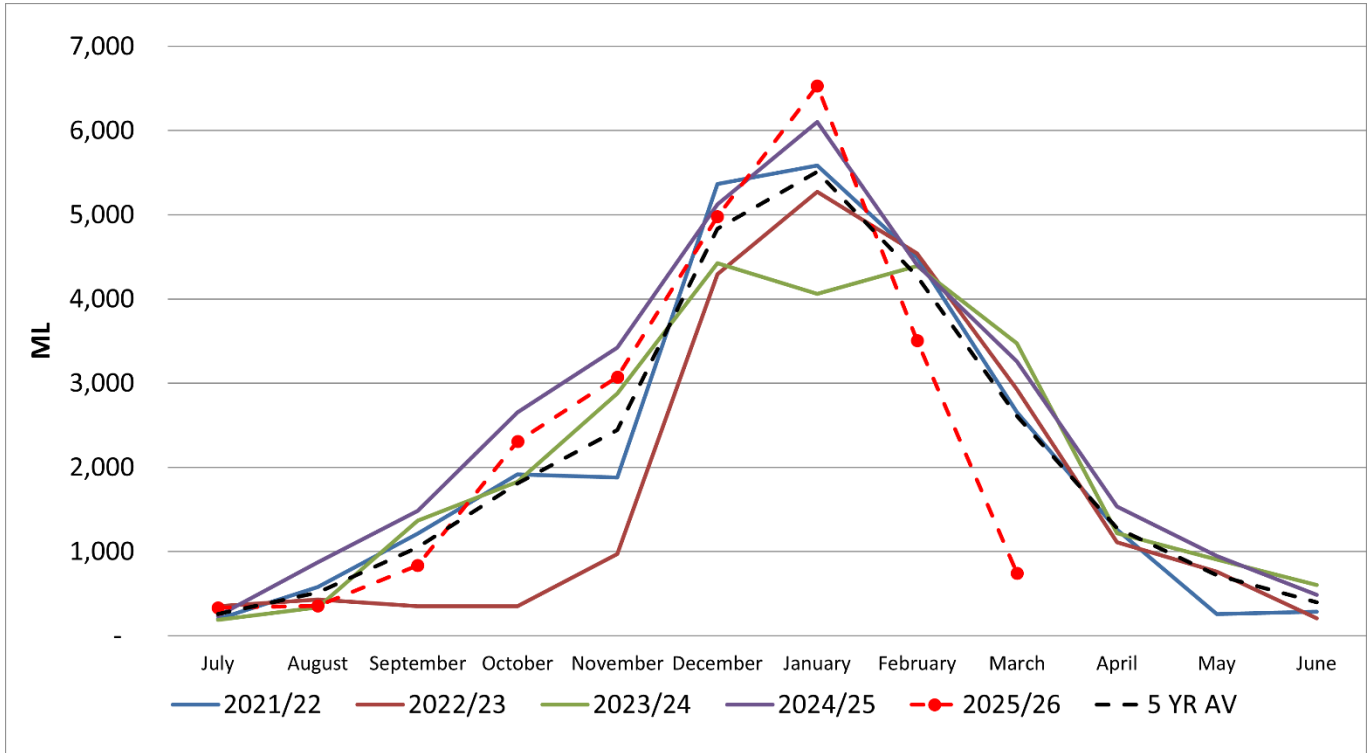
Australia Government's Rural Financial Counselling

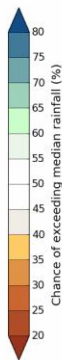
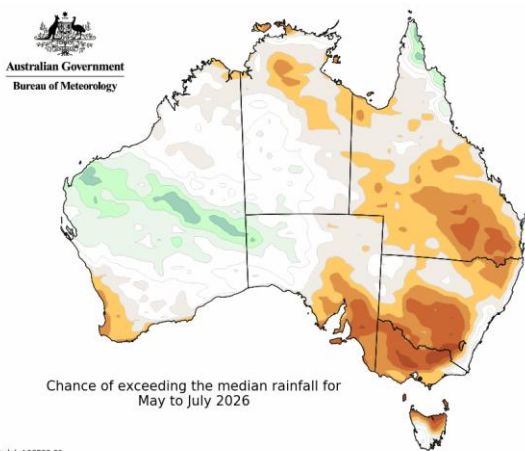
We understand some customers may be experiencing financial pressure. If you are having difficulty paying your quarterly account, please contact our office early so we can work with you on suitable payment arrangements.

Total Water Pumped Over 5 Years; including Year to Date

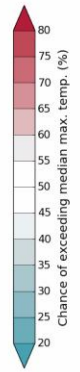
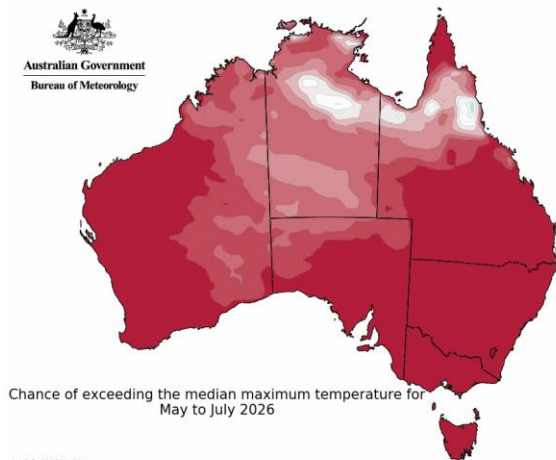


Climate Outlook: May to July 2026
